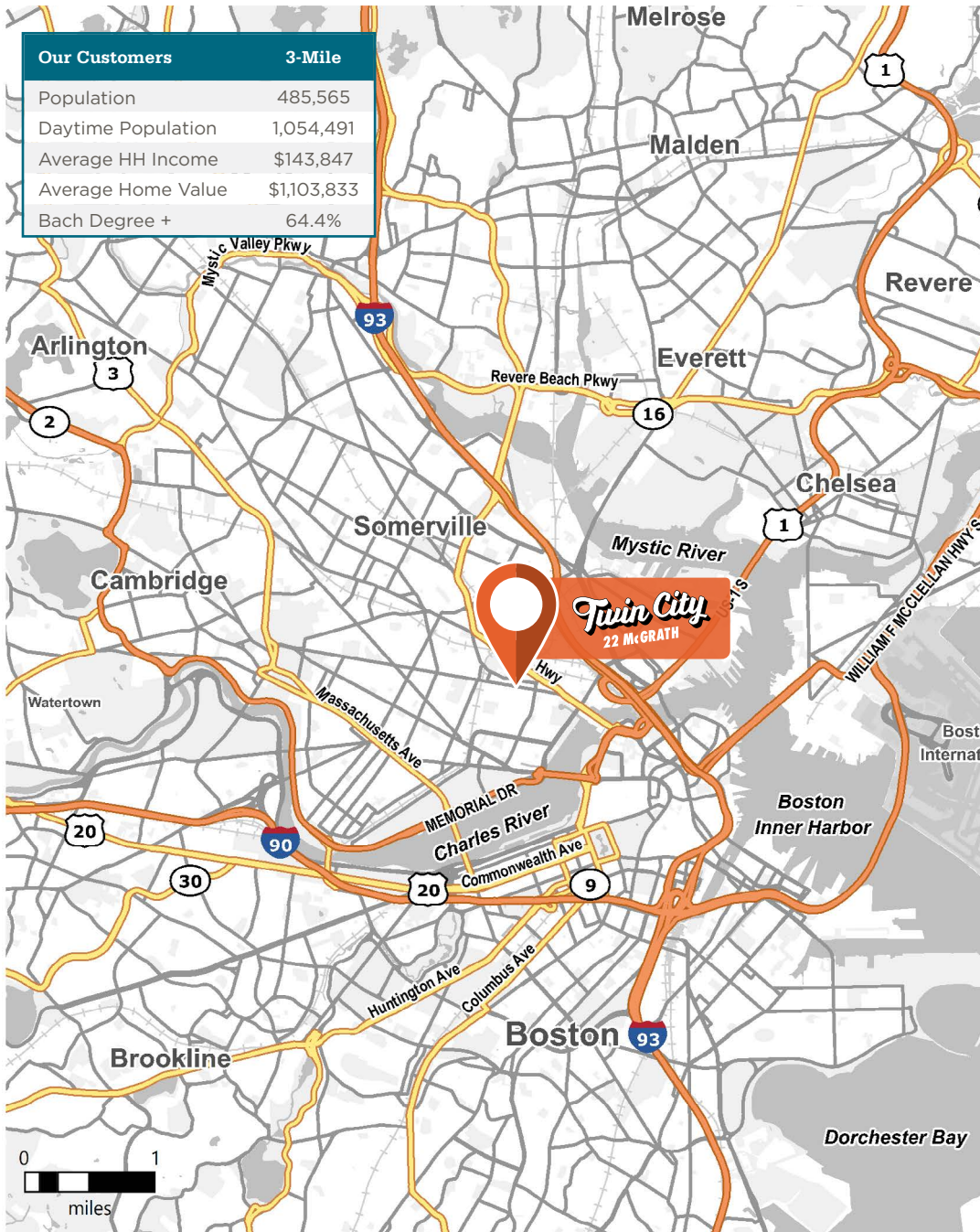

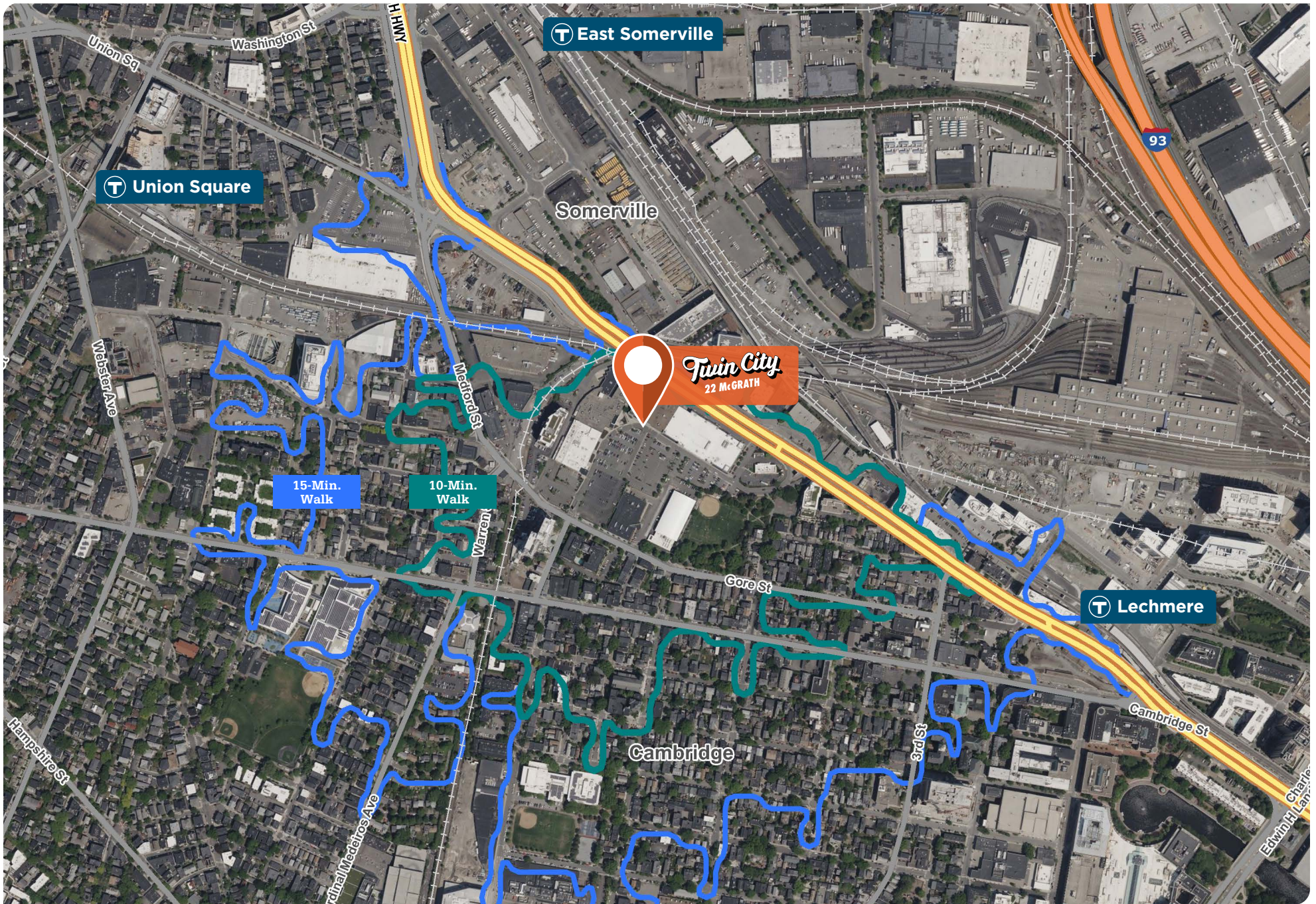
It will transform completely with an upgraded appearance, improved placemaking, and an elevated merchandising mix.
